- organisation and I can't think why I was there now. I think I did have a membership card but it was all so long ago now.
- Some of the people in these groups were really nice, pleasant, intelligent people. They were different politically in their views but in this country you can have different political views.
  - 13 There were a couple of people in the ILP that I was close to. I was friendly but not too friendly because you've still got to distance yourself. I remember *Name*, who was an older man even back then. There was also *Name*. I would be amazed if these people were still alive.

There is no record of me being there and no photographs were taken of me. I had to go because I was invited; I could hardly avoid going.

# Confidentiality

- Discretion and secrecy was the order of the day sturn und krum. Say nothing about anything. This was communicated to me right from the very start. Even other members of my unit were not aware of my undercover name and which groups I infiltrated. It was very much "keep quiet about the whole thing". To be honest, I can't recall a conversation about secrecy at the end of my deployment. It was just the nature of the job that you didn't talk about it.
- I was always careful about looking over my shoulder to make sure I wasn't being followed. At the time of my deployment, I was living with my parents. I told them I was on the Drugs squad; I didn't tell them what I was actually doing. They are both deceased now.
- The media revelations have made me think that too many people have been talking too much about things that I have always understood to be secret. This bloke Francis has stirred it all up and I wonder how much truth is in the allegations that he's making. I think the whole thing has been blown out all proportion. But then, other people have fathered children and you can't have that.

# Conclusion

I would like anonymity over my real name. I suppose my cover name is less important, you couldn't identify me from my cover name. What I am most concerned about is having my personal details and address being put out in the public domain. I have a vivid recollection of what happened to one of my friends when he was doorstepped at home causing him and his wife untold grief. The press, activists and lawyers could cause all manner of problems. I don't want to be exposed to that. Some of these people have been up to naughties but there was nothing like that in my day. I don't want the interference at my stage of life. I want to quietly go off into obscurity.
