

COUNSEL TO THE INQUIRY'S EXPLANATORY NOTE TO ACCOMPANY THE CHAIRMAN'S 'MINDED TO' NOTE 12 IN RESPECT OF APPLICATIONS FOR RESTRICTIONS OVER THE REAL AND COVER NAMES OF OFFICERS OF THE SPECIAL OPERATIONS SQUAD AND THE SPECIAL DEMONSTRATION SQUAD

UPDATE as at 13th September 2018

Introduction

1. On 3 August 2017, 23 October 2017, 15 November 2017, 15 January 2018, 25 January 2018, 7 March 2018, 22 March 2018, 28 March 2018, 26 April 2018, 23rd May 2018, 21st June 2018 and 30th July 2018 the Chairman published 'Minded To' and 'Supplementary Minded To' notes regarding applications by the Metropolitan Police Service to the Inquiry for restriction orders regarding the real and/or cover names of a number of Special Demonstration Squad officers.
2. This is an update to Counsel's Explanatory Notes published on 3 August 2017, 15 November 2017, 15 January 2018, 25 January 2018, 7 March 2018, 22 March 2018, 28 March 2018, 26 April 2018, 23 May 2018, 21 June 2018 and 30th July 2018.
