1. The following information has been received from a reliable source:-
2. "On Thursday 26th June, 1969, an emergency meeting of the London Region B.V.S.F. was held at the Union Tavern, Lloyd Baker Street, W.C.1. between 8 p.m. and 10 p.m. The agenda for the meeting was:
 - 1) The role of the BATESON's and IBRAHIM in the B.V.S.F.
 - 2) The expulsion of the above mentioned.
 - 3) Election of new officers and executive committee.
 - 4) Forthcoming plans for B.V.S.F.
3. The meeting was chaired by Harpel BRAR, who explained briefly the reasons for the meeting and then asked Al. MANCHANDA to give an account of the BATESON's and IBRAHIM's revisionist activities over the past two years. This MANCHANDA did at great length. There was a short discussion about his speech, the only opposition coming from [redacted] Privacy who, whilst not challenging the facts contained within MANCHANDA's speech, argued that it was not based on sound Marxist-Leninist principles.
4. BRAR then put the proposal that Nick [redacted] Privacy BATESON and Fawzi IBRAHIM should be expelled from B.V.S.F. for one year, and the motion was carried.
