2. Privacy, the tenant at [Redacted] is officially registered as 'unemployed' and receives Social Security benefits. However, he spends money Privacy freely and it seems likely that he derives most of his income from the proceeds of crime. Privacy

3. Privacy and his wife, Privacy, are aware of their lack of political education and are currently seeking to improve their knowledge by an intensive study of various left wing publications including the works of Marx and Engels. Privacy is, nevertheless, an influential member of the 'Shrewsbury 24 Defence Committee' and is in regular contact with all the leading members of that group. Privacy is also a close associate of Privacy, the London organiser of PROF (Preservation of the Rights of Prisoners) and is himself an active member of the organisation. He has been responsible for at least two demonstrations at the London Polytechnic to raise funds for PROF.

4. Although Privacy is as much criminally as politically active, he encourages the use of his home as a forum for political lectures despite the fact that he has recently indicated his distaste for Privacy 'Stalinist' dogmatism. Privacy seems to prefer a genuine exchange of political viewpoints.

5. Privacy, formerly a keen participant in the classes, now seems to have lost interest and is understood to be engaged in private research of a wide range of Trotskyist and Anarchist literature. She seems to be as yet undecided about joining any particular political group. She has a half-caste daughter aged about four years and currently shares a top floor flat at Privacy, with Privacy and her half-caste son. Privacy is employed as a 'Girl Friday' at the Privacy Law Centre and is involved in this way with local community politics.
