SUBJECT

1. The following information has been received from a reliable source:-

2. [Privacy] of [Privacy] [Privacy] (Tel: [Privacy]) is an active participant in left-wing politics and has recently helped to form the Revolutionary Marxist Tendency.

3. [Privacy] was born in [Privacy] on [Privacy] and first registered with police in the United Kingdom on [Privacy]. His 'leave to land' expired on 9.6.80 although it is believed that this has recently been renewed. He is currently employed as a salesman for a South African based company at [Privacy].

[Privacy]

4. On [Privacy] at Stoke Newington, [Privacy] was married to [Privacy] a British subject. He underwent the ceremony as a measure to protect his right of residence in the United Kingdom, known in common parlance as a 'marriage of convenience', should his political activities incur the interest of the British authorities. The marriage appears never to have been consummated and [Privacy] has flatly refused since the ceremony even to co-habit with [Privacy]. This is a matter of great concern to [Privacy] as he considers it probable that [Privacy] would not go out of her way to protect him should the need arise. Further, recent attempts by [Privacy] to recruit [Privacy] into the Revolutionary Marxist Tendency appear to have resulted only in further straining of their relationship.

5. [Privacy] is presently indulging in a sexual relationship with [Privacy] also a founding member of the Revolutionary Marxist Tendency, who has recently moved into [Privacy]'s flat. Judging by the depressing regularity with which [Privacy] suffers from attacks of cystitis, neither is permitting [Privacy]'s tenuous position in the United Kingdom to interfere with more immediate needs.

6. [Privacy] claims that he was active within left-wing politics while living in [Privacy] to such an extent that the [Redacted] domestic intelligence agency maintained a constant surveillance upon him. His statement is the subject of some doubt however amongst other members of the Revolutionary Marxist Tendency. Upon coming to the U.K. [Privacy] became associated with the Revolutionary Communist Tendency (RCT) for approximately 18 months during which time, it is claimed, he was responsible for initiating and improving the party security system. Due to the rejection of a number of his proposals he resigned or was expelled from the R.C.T.

7. On leaving the MCT, [Privacy] spent some months in political isolation, although he continued political discussions with [Privacy] [Privacy] and other R.O.T. malcontents. Eventually [Privacy] came into contact with members of the Revolutionary Labour League, an extremely small group, but obviously sufficiently useful for [Privacy] to break out of his political isolation. As a result of subsequent discussions the Revolutionary Labour League merged with [Privacy] and [Privacy] to form the Revolutionary Marxist Tendency. [Privacy] has subsequently injected a not inconsiderable amount of cash into the organisation probably approaching £650 at the present time, and has pledged a minimum of £2,000. Additionally he has arranged for [Privacy] to work full-time for the group once office accommodation has been found.

8. The future of the Revolutionary Marxist Tendency at this time looks bleak. [Privacy] has persistently refused to furnish the former members of the R.L.L. with any personal details although he has intimated that he is currently applying for British citizenship and has displayed definite tendencies towards being a little 'Joe Stalin', which have far from endeared him to his new associates. Regardless, however, of the outlook for this organisation, it is fair to say that [Privacy] has shown a considerable ability to organise, direct, write and explain ideological pamphlets and an obvious willingness to back up his beliefs and ideas with hard cash. His exact motives can at this stage remain only a matter of conjecture.

9. [Privacy] is described as under:-

Height 5'10", heavy build; wears heavy horn rimmed spectacles which, due to prolonged problems with [medical details], are of a high magnification. He apparently suffers [medical details] and, to keep it under control devours large amounts of food."
