- 3. MPSB files fall into two main categories:
 - 1) Personal files which contain information relating to a specific subject of counter terrorism or domestic extremism interest; and
 - 2) Bulk files which contain information relating to either a specific topic or a miscellaneous area of counter terrorism or domestic extremism

Files were organised by their year of creation and by their RF or "cut" number which denoted the subject or topic of each file i.e. the "cut" number for a file created in 2000 which related to SB policy would begin 361/00/1.


Whilst every effort was made to ensure that the correct "cut" number was assigned to either an individual or group there may have been occasions when the "cut" number was incorrect. The reasons behind this could be that the initial reporting pointed towards a group or ideology that then changed to a different subject area or simple human error when assigning a "cut" number.
