Since March 9th 1969, Privacy has been in open conflict with MANCHANDA, (this matter is being dealt with in a separate report).

Privacy to account for his failure to conduct himself in a "correct" manner, but Privacy was obviously intent on sabotaging B.V.S.F.for his own opportunist motives. MANCHANDA said that he had in fact received Privacy s resignation on 10th May, 1969, and he called on members to discuss this matter. As a result Privacy then read a letter which he had prepared, addressed to the National Executive of B.V.S.F. calling its attention to the fact that Privacy had not performed his duties as secretary for some months and that he should therefore be called upon to explain his actions. This letter was then signed by all those present, and apart from further general discussion on the role of the Privacy and their supporters, no other topics were raised.
