# 1. THE CURRENT STATE OF EMERGENCY

SIR JOHN HUNT sought the views of the Group on how publicity might appropriately be given to the subversive aspects of the current emergencies. In the light of the subsequent discussion, he undertook to reflect their views in a submission to the Prime Minister.

## 3. SUB-GROUP UNDER MR J E PESTELL

MR HAYDON said that, as members of the Group were individually aware, a Sub-Group, consisting of representatives of the Department of Employment and the Department of Trade and Industry under the Chairmanship of Mr Pestell, had been set up to consider whether any information on industrial disputes compiled for overt use with the Press could also be used less directly and, with Ministerial approval, to use it in this way. The Sub-Group had met once and had implemented one project - the feeding in of questions to a "Talk-in" programme featuring Mr Lawrence Daly.

4, MINISTERIAL AUTHORITY FOR PROJECTS

THE CHAIRMAN reminded the group that its terms of reference prescribed that the implementation of its projects should be subject to Ministerial approval.

MR HE ON confirmed that, when the Sub-Group on Industry had initiated projects which were not merely natural extensions of the work of IRD or of the Information staff of the Department of Employment, he had sought prior Ministerial approval through Sir Donald Maitland; he would continue to do likewise through Mr Haydon.

MR HAYDON confirmed that Ministerial approval had been given for the one project so far initiated by the Sub-Group under the chairmanship of Mr Pestell.

5. INTERDEPARTMENTAL GROUP UNDER THE CHAIRMANSHIP
OF MR WADDELL
Previous Reference: 1714(72) 3rd Meeting, Minute 2

MR WADDELL said that his group had so far met nine times. It was steadily producing a series of reports on different trade unions and had also reported on the security significance of the ultra left in the United Kingdom in 1973.

In discussion, these reports were welcomed as handy works of reference which in particular reflected profitable collaboration between the Security Service and the Department of Employment.
